RE: SCOPE RULING ON ANTIDUMPING DUTY ORDER ON CERTAIN CARBON STEEL BUTT-WELD PIPE FITTINGS FROM JAPAN (A-588-602)

1. ON 06/25/2009, IN RESPONSE TO A REQUEST BY BENEX CORPORATION, COMMERCE ISSUED A FINAL SCOPE RULING THAT TEE BLANKS (ALSO KNOWN AS "AS-FORGED TEES") ARE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING CERTAIN CARBON STEEL BUTT-WELD PIPE FITTINGS FROM JAPAN (A-588-602).

2. BECAUSE THE IMPORTED PRODUCTS ARE IN THE SHAPE OF TEES AND ADVANCED AFTER FORGING, THE COMMERCE DEPARTMENT FOUND THIS PRODUCT TO BE WITHIN THE SCOPE OF THE ORDER.

3. CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES OF CERTAIN CARBON STEEL BUTT-WELD PIPE FITTINGS FROM JAPAN, INCLUDING BENEX CORPORATION'S TEE BLANKS AND/OR AS-FORGED TEES, SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING CERTAIN CARBON STEEL BUTT-WELD PIPE FITTINGS FROM JAPAN.
