COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (74 FR 31242) ON 06/30/2009 THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF A CERTAIN MANUFACTURER/EXPORTER SUBJECT TO THE ANTIDUMPING ORDER ON CERTAIN WELDED STAINLESS STEEL PIPE FROM THE REPUBLIC OF KOREA FOR THE PERIOD 12/01/2006 THROUGH 11/30/2007.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATE HAS BEEN REVISED FOR A CERTAIN MANUFACTURER/EXPORTER. THEREFORE,

FOR SHIPMENTS OF CERTAIN WELDED STAINLESS STEEL PIPE FROM THE REPUBLIC OF KOREA ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 06/30/2009, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING MANUFACTURER/EXPORTER:

3. IF ANY ENTRIES OF MERCHANDISE ARE EXPORTED BY A FIRM OTHER THAN THE MANUFACTURER, THEN THE FOLLOWING INSTRUCTIONS APPLY:

4. FOR ALL MANUFACTURERS/EXPORTERS OF CERTAIN WELDED STAINLESS STEEL PIPE FROM THE REPUBLIC OF KOREA WITHOUT THEIR OWN RATE, THE CASH DEPOSIT RATE IS 7.00 PERCENT.

5. THESE CASH DEPOSIT REQUIREMENTS SHALL REMAIN IN EFFECT UNTIL FURTHER NOTICE. DO NOT LIQUIDATE ANY ENTRIES OF MERCHANDISE INCLUDED IN THIS ADMINISTRATIVE REVIEW UNTIL ASSESSMENT INSTRUCTIONS ARE RECEIVED.
