RE: LIQUIDATION INSTRUCTIONS BASED UPON PARTIAL REVOCATION OF ADD ORDER ON BALL BEARINGS AND PARTS THEREOF FROM GERMANY (A-428-201-006); GEBRUEDER REINFURT GMBH & CO.

1. COMMERCE HAS REVOKED THE ANTIDUMPING DUTY ORDER ON BALL BEARINGS AND PARTS THEREOF FROM GERMANY IN PART AND PUBLISHED THE REVOCATION IN THE FEDERAL REGISTER ON 08/31/2009. THE PARTIAL REVOCATION APPLIES TO ALL SUBJECT MERCHANDISE EXPORTED AND/OR SOLD BY GEBRUEDER REINFURT GMBH & CO., KG (GRW) (A-428-201-006), AND THE EFFECTIVE DATE OF THE REVOCATION IS 05/01/2008.

2. THEREFORE, CBP IS DIRECTED TO TERMINATE THE SUSPENSION OF LIQUIDATION FOR ALL SHIPMENTS OF BALL BEARINGS AND PARTS THEREOF FROM GERMANY WHICH WERE EXPORTED AND/OR SOLD BY GEBRUEDER REINFURT GMBH & CO., KG (GRW) (AS INDICATED ON THE COMMERCIAL INVOICE OR CUSTOMS DOCUMENTATION), AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 05/01/2008. ALL ENTRIES OF THE SUBJECT MERCHANDISE MEETING THE ABOVE DESCRIPTION THAT WERE SUSPENDED ON OR AFTER 05/01/2008 SHOULD BE LIQUIDATED WITHOUT REGARD TO ANTIDUMPING DUTIES (I.E., RELEASE ALL BONDS AND REFUND ALL CASH DEPOSITS).

3. NOTICE OF THE LIFTING OF SUSPENSION OF LIQUIDATION OF ENTRIES OF SUBJECT MERCHANDISE ENTERED, OR WITHDRAWN FROM WAREHOUSE, ON OR AFTER 05/01/2008 OCCURRED WITH THE PUBLICATION OF THE NOTICE OF REVOCATION IN PART IN THE FEDERAL REGISTER (74 FR 44819, 08/31/2009).

4. THE ASSESSMENT OF ANTIDUMPING DUTIES BY CBP ON SHIPMENTS OR ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. SECTION 778 REQUIRES THAT CBP PAY INTEREST ON OVERPAYMENTS OR ASSESS INTEREST ON

UNDERPAYMENTS OF THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED ANTIDUMPING DUTIES.

THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED ANTIDUMPING DUTIES BEFORE THE DATE OF PUBLICATION OF THE ANTIDUMPING DUTY ORDER.

INTEREST SHALL BE CALCULATED FROM THE DATE PAYMENT OF ESTIMATED ANTIDUMPING DUTIES IS REQUIRED THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.
