OF CERTAIN MANUFACTURERS/EXPORTERS SUBJECT TO THE ANTIDUMPING  
ORDER ON BALL BEARINGS AND PARTS THEREOF FROM GERMANY FOR THE  
PERIOD 05/01/2007 THROUGH 04/30/2008.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES

6. COMMERCE HAS REVOKED THE ANTIDUMPING DUTY ORDER WITH RESPECT TO MERCHANDISE EXPORTED AND/OR SOLD BY GEBRUEDER REINFURT GMBH & CO., KG (GRW) (A-428-201-006). SEPARATE INSTRUCTIONS CONCERNING THE REVOCATION WILL BE ISSUED.
