1. COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (74 FR 47198) ON 09/15/2009 THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF CERTAIN MANUFACTURERS SUBJECT TO THE ANTIDUMPING ORDER ON STAINLESS STEEL BAR FROM INDIA FOR THE PERIOD 02/01/2007 THROUGH 01/31/2008.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES HAVE BEEN REVISED FOR CERTAIN MANUFACTURERS. THEREFORE, FOR SHIPMENTS OF STAINLESS STEEL BAR FROM INDIA ENTERED, OR

WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 09/15/2009, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING MANUFACTURERS:
