RE: Preliminary injunction on circular welded non-alloy steel pipe from the Republic of Korea for SeAH Steel Corporation for the period 11/01/2009 through 10/31/2010 (A-580-809), court number 12-00189

1. On 09/04/2013, the U.S. Court of International Trade issued a preliminary injunction enjoining liquidation of certain entries which are subject to the antidumping duty order on circular welded non-alloy steel pipe from the Republic of Korea (A-580-809) for the period 11/01/2009 through 10/31/2010.

2. This injunction was issued in connection with court case number 12-00189 and enjoins liquidation of the entries described in paragraph 3 below.

3. Accordingly, until further notice, do not liquidate entries of subject merchandise which are subject to the final results of antidumping duty administrative review (77 FR 34344, 06/11/2012), were produced and exported by SeAH Steel Corporation and imported by Pusan Pipe America and which were entered, or withdrawn from warehouse, for consumption during the period 11/01/2009 through 10/31/2010. Continue to suspend liquidation of these entries until liquidation instructions are issued:

4. The injunction applies to the liquidation instructions in message number 2179306, dated 06/27/2012.

5. The same merchandise is also currently covered by an injunction under court case number 12-00180. See message number 2188302 (07/06/2012).

6. Effective immediately, CBP is instructed to prevent liquidation of any entries subject to the above.

7. The court entered this injunction on the docket of the case on 09/04/2013. Pursuant to the terms of the injunction, no liquidation of the entries covered by the injunction may be made for entries which remain unliquidated as of 5:00 p.m. Eastern Standard Time on the fifth business day after 09/04/2013 when the Court entered this order on the docket in this case, which is

09/11/2013.
