1. These instructions correct E-Mail 2002111 of January 2, 1992 regarding liquidation of entries of cement from Mexico made on or after April 12, 1990 and on or before July 31, 1991 (antidumping duty order A-201-802).

2. Number 5 of the referenced instructions should be corrected to read: Accordingly, under the antidumping duty order on cement from Mexico you are to liquidate all entries for all firms except Cemex S.A., and Apasco S.A., DE C.V. of cement from Mexico made on or after April 12, 1990 and on or

before July 31, 1991 at the cash deposit rate plus 1.44 percent to insure that all applicable antidumping duties are collected.
