INVESTIGATION OF NEPHELINE SYENITE FROM CANADA

1. THE COMMERCE DEPARTMENT HAS PUBLISHED IN THE FEDERAL REGISTER ON MARCH 17, 1992, NOTICE OF ITS FINAL DETERMINATION THAT NEPHELINE SYENITE FROM CANADA IS BEING SOLD IN THE UNITED STATES AT LESS THAN FAIR VALUE.

2. AFTER SOLICITING COMMENTS FROM INTERESTED PARTIES, THE DEPARTMENT HAS AMENDED THE SCOPE OF THE INVESTIGATION TO THE FOLLOWING: THE PRODUCT COVERED BY THIS INVESTIGATION IS NEPHELINE SYENITE (NS). FOR PURPOSES OF THIS INVESTIGATION,

NS IS A COARSE, CRYSTALLINE ROCK CONSISTING PRINCIPALLY OF FELDSPATHIC MINERALS (I.E., SODIUM-POTASSIUM FELDSPARS AND NEPHELINE), WITH LITTLE OR NO FREE QUARTZ, AND WHOSE TYPICAL MEAN VALUE PASSING THROUGH ASTM E-11 MESH SIEVE NO. 40 AND RETAINED ON ASTM E-11 MESH SIEVE NO. 200 (WHEN SOLELY SAID TWO SIEVES ARE USED) IS NO LESS THAN 70 PERCENT BY WEIGHT. NS IS CURRENTLY CLASSIFIABLE UNDER ITEM 2529.30.0010 OF THE HARMONIZED TARIFF SCHEDULE (HTS). ALTHOUGH THE HTS ITEM NUMBER IS PROVIDED FOR CONVENIENCE AND CUSTOMS PURPOSES, OUR WRITTEN DESCRIPTION OF THE SCOPE OF THIS PROCEEDING IS DISPOSITIVE.

3. FOR FURTHER REPORTING PURPOSES THIS CASE HAS BEEN ASSIGNED INVESTIGATION NUMBER A-122-813. THIS NUMBER SHOULD BE USED WHEN DEALING WITH THE DEPARTMENT OF COMMERCE.

4 THE U.S. CUSTOMS SERVICE SHALL CONTINUE TO SUSPEND LIQUIDATION OF ENTRIES THAT ARE ENTERED OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION ON OR AFTER DECEMBER 27, 1991.

EFFECTIVE MARCH 17, 1992, CUSTOMS SHALL REQUIRE A CASH DEPOSIT OR THE POSTING OF A OND EQUAL TO THE ESTIMATED FINAL MARGIN PERCENTAGES LISTED BELOW:
