RE: Temporary Restraining Order on certain frozen warmwater shrimp from India (A-533-840), court number 13-00283

1. On 08/23/2013 the U.S. Court of International Trade issued a Temporary Restraining Order (TRO) enjoining liquidation of certain entries of merchandise which was the subject of the final results of administrative review (78 FR 42492, July 16, 2013), produced and/or exported from India by the firms listed below and entered, or withdrawn from warehouse, for consumption during the period 02/01/2011 through 01/31/2012:

2. This TRO was issued in connection with court case number 13-00283 and enjoins liquidation of the entries described above. This TRO shall be effective for all entries which remain unliquidated as of 5:00 p.m. on 08/23/2013 and shall remain in effect until 08/30/2013.
3. This TRO applies to the liquidation instructions in message numbers 3218302 and 3227305 dated 08/06/2013 and 08/15/2013, respectively.
4. Accordingly, effective 08/23/2013 and until 08/30/2013, CBP is instructed not to liquidate entries of merchandise subject to the TRO as described in paragraph 1. Any entries that are set for liquidation must be unset immediately.
