THE NOTICE OF THE INITIATION OF REVIEW WAS PUBLISHED IN THE FEDERAL REGISTER ON MARCH 4, 1998.

2. FOR SHIPMENTS OF CERTAIN PASTA FROM ITALY ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION IN THE UNITED STATES ON OR AFTER MARCH 4, 1998, A BOND OR OTHER SECURITY DEPOSIT IS

PERMITTED, AT THE IMPORTER'S OPTION, FOR THE FOLLOWING NEW MANUFACTURERS/EXPORTERS:

4. FOR ALL OTHER ITALIAN MANUFACTURERS/EXPORTERS OF CERTAIN PASTA FROM ITALY WHICH DO NOT HAVE A SPECIFIC RATE IN THE MODULE, THE CASH DEPOSIT CONTINUES TO BE 11.26 PERCENT.

5. THE OPTION OF A BOND IN LIEU OF A CASH DEPOSIT WILL REMAIN IN EFFECT FOR CO.R.EX. S.R.L. UNTIL PUBLICATION OF THE FINAL RESULTS OF THE NEW SHIPPER ADMINISTRATIVE REVIEW.
