RE: Notice of final determination in the countervailing duty investigation of certain frozen warmwater shrimp from the Socialist Republic of Vietnam (C-552-815)

1. On 08/19/2013, Commerce published in the Federal Register its affirmative final determination in the countervailing duty investigation of certain frozen warmwater shrimp from the Socialist Republic of Vietnam (Vietnam) (78 FR 50387).
2. The products covered by this investigation are described in message 3028303 dated 01/28/2013.
3. This investigation has been assigned investigation number C-552-815.
4. For imports of certain frozen warmwater shrimp from Vietnam, CBP shall continue to suspend liquidation of such shipments entered, or withdrawn from warehouse, for consumption on or after 06/04/2013. Effective 08/19/2013, CBP shall require, for such entries, a cash deposit equal to the subsidy rates for the following companies listed below:
