ON OR AFTER 05/29/2009, DISSOLVED ON 10/01/2009.

2. UNTIL FURTHER NOTICE CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES. DO NOT LIQUIDATE ANY ENTRIES OF THIS MERCHANDISE UNTIL SPECIFIC LIQUIDATION INSTRUCTIONS ARE RECEIVED.
