FOR SHIPMENTS OF CERTAIN PASTA FROM ITALY ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER JULY 24, 1996, A CASH DEPOSIT, AT THE ALL OTHERS' RATE ESTABLISHED IN THE AMENDED FINAL DETERMINATION OF SALES AT LESS THAN FAIR VALUE (61 FR 38547), IS REQUIRED FOR THE FOLLOWING EXPORTER:

DO NOT LIQUIDATE ANY SHIPMENTS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER JANUARY 19, 1996, UNTIL YOU HAVE RECEIVED LIQUIDATION INSTRUCTIONS COVERING THIS PERIOD.
