RE: SCOPE RULING ON ANTIDUMPING DUTY ORDER ON PETROLEUM WAX CANDLES FROM THE PRC

1. ON SEPTEMBER 6, 1997, IN RESPONSE TO A REQUEST BY MEIJER, INC. (MEIJER), THE DEPARTMENT OF COMMERCE ISSUED A FINAL SCOPE RULING THAT CANDLES IN TERRA COTTA CONTAINERS (BELL, TREE, REINDEER, AND STAR) ARE WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING PETROLEUM WAX CANDLES FROM THE

PEOPLE'S REPUBLIC OF CHINA (A-570-504). IN ADDITION, THE COMMERCE DEPARTMENT ALSO RULED THAT MEIJER'S JACK-O-LANTERN CANDLE, HELD IN A CERAMIC CONTAINER, IS OUTSIDE THE SCOPE OF

THE ORDER.

2. BECAUSE FOUR OF MEIJER'S IMPORTED PRODUCTS REPRESENT REGULAR CANDLES IN TERRA COTTA CONTAINERS (BELL, TREE, REINDEER, AND STAR), THE COMMERCE DEPARTMENT FOUND THESE PRODUCTS TO BE WITHIN THE SCOPE OF THE ORDER ON PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA.

3. IN ADDITION, BECAUSE MEIJER'S JACK-O-LANTERN CANDLE CAN SPECIFICALLY BE ASSOCIATED WITH THE HALLOWEEN HOLIDAY SEASON, THE COMMERCE DEPARTMENT FOUND THIS PRODUCT TO BE OUTSIDE THE SCOPE OF THE ORDER ON PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA.

3. CONTINUE TO SUSPEND LIQUIDATION OF ENTRY SUMMARIES OF PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA, INCLUDING MEIJER'S BELL, TREE, REINDEER, AND STAR CANDLES, LISTED ABOVE, SUBJECT TO THE ANTIDUMPING DUTY ORDER COVERING PETROLEUM WAX CANDLES FROM THE PEOPLE'S REPUBLIC OF CHINA.

4. IN ADDITION, EFFECTIVE SEPTEMBER 6, 1997, TERMINATE SUSPENSION AND LIQUIDATE ALL UNLIQUIDATED ENTRY SUMMARIES, REGARDLESS OF ENTRY SUMMARY DATE, OF MEIJER'S "JACK-O-LANTERN" CANDLE LISTED ABOVE.

5. REFUND ANY CASH DEPOSITS WITH INTEREST AND RELEASE ANY BONDS RELATING TO THE "JACK-O-LANTERN" CANDLE LISTED ABOVE.

6. IF THERE ARE ANY QUESTIONS REGARDING THIS MATTER BY CUSTOMS OFFICERS, PLEASE CONTACT VIA E-MAIL, THROUGH THE APPROPRIATE SUPERVISORY CHANNELS, TRADE COMPLIANCE DIVISION, ANTIDUMPING/COUNTERVAILING DUTY, USING THE ATTRIBUTE "HQ OAB."
