ON DECEMBER 4, 1998, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE COUNTERVAILING DUTY ORDER ON CERTAIN PASTA FROM ITALY (C-475-819), MANUFACTURED OR EXPORTED BY DELVERDE SRL (C-475-819-008), DELVERDE USA, INC., AND/OR ITS AFFILIATE, TAMMA INDUSTRIE ALIMENTARI DI CAPITANATA SRL.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WAS PRODUCED OR EXPORTED BY DELVERDE SRL, DELVERDE USA, INC., AND/OR TAMMA INDUSTRIE ALIMENTARI DI CAPITANATA, SRL AND WHICH WAS BEEN ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD OCTOBER 17, 1995, THROUGH FEBRUARY 13, 1996, AND JULY 24, 1996, THROUGH DECEMBER 31, 1996. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.

3.
