ON MARCH 13, 1992, IN RESPONSE TO A REQUEST BY MOTOROLA, INC., THE DEPARTMENT ISSUED A FINAL SCOPE RULING THAT HIGH-CAPACITY PAGER COMPONENTS AND SUBASSEMBLIES, FOR INCORPORATION INTO TONE-ONLY HIGH-CAPACITY PAGERS, IMPORTED FROM JAPAN ARE NOT WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER ON CERTAIN HIGH-CAPACITY PAGERS FROM JAPAN.

2. EFFECTIVE IMMEDIATELY, TERMINATE SUSPENSION AND LIQUIDATE ALL UNLIQUIDATED ENTRIES, REGARDLESS OF ENTRY DATE, OF THE

ABOVE LISTED PRODUCTS.

3. REFUND ANY CASH DEPOSITS AND RELEASE ANY BONDS RELATING TO THE ABOVE LISTED PRODUCTS.
