1. THE DEPARTMENT OF COMMERCE HAS COMPLETED AN
ADMINISTRATIVE REVIEW OF THE ANTIDUMPING DUTY ORDER ON CERTAIN
STAINLESS STEEL COOKING WARE FROM THE REPUBLIC OF KOREA AND
PUBLISHED THE FINAL RESULTS IN THE FEDERAL REGISTER ON AUGUST
12, 1991 (56 FR 38114).

2. IMPORTS COVERED BY THIS REVIEW ARE SHIPMENTS OF CERTAIN
STAINLESS STEEL COOKING WARE FROM THE REPUBLIC OF KOREA. THE
PRODUCTS COVERED BY THIS ORDER ARE SKILLETTS, FRYING PANS

OMELETTE PANS, SAUCEPANS, DOUBLE BOILERS, STOCK POTS, DUTCH OVENS, CASSEROLES, STEAMERS, AND OTHER STAINLESS STEEL VESSELS, ALL FOR COOKING ON STOVE TOP BURNERS, EXCEPT TEAKETTLES AND FISH POACHERS. EXCLUDED FROM THE SCOPE ARE STAINLESS STEEL KITCHEN WARE. SUCH MERCHANDISE IS CLASSIFIABLE UNDER HARMONIZED TARIFF SCHEDULE (HTS) ITEM NUMBERS 7323.93.00 AND 9604.00.00. THE WRITTEN DESCRIPTION REMAINS DISPOSITIVE.

3. THE CASH DEPOSIT RATE FOR NAMIL METAL LTD. (A-580-601-005) IS 1.69 PERCENT FOR SHIPMENTS OF THE SUBJECT MERCHANDISE ENTERED, OR WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION ON OR AFTER AUGUST 12, 1991.

4. THE CASH DEPOSIT REQUIRED FOR PREVIOUSLY REVIEWED OR INVESTIGATED MANUFACTURERS/EXPORTERS WILL BE THE RATE INDICATED IN THE AD/CVD MODULE. FOR ANY ENTRIES OF THIS MERCHANDISE FROM A NEW EXPORTER, NOT COVERED IN THIS OR PRIOR ADMINISTRATIVE REVIEWS, WHOSE FIRST SHIPMENTS OF CERTAIN STAINLESS STEEL COOKING WARE OCCURRED AFTER DECEMBER 31, 1989, AND WHO IS UNRELATED TO THE REVIEWED FIRM, A CASH DEPOSIT OF 1.69 SHALL BE REQUIRED.

5. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS OF THE NEXT ADMINISTRATIVE REVIEW.

6. DO NOT LIQUIDATE ANY ENTRIES OF THIS MERCHANDISE INCLUDED IN THIS ADMINISTRATIVE REVIEW UNTIL APPRAISEMENT INSTRUCTIONS ARE ISSUED .
