2. AS A RESULT OF THE CHANGED-CIRCUMSTANCES REVIEW, COMMERCE HAS DETERMINED THAT SKF (UK) LTD. IS THE SUCCESSOR-IN-INTEREST TO SNFA BEARINGS LTD. (LISTED IN THE AD/CVD MODULE AS SNFA

U.K.). THEREFORE, SNFA BEARINGS LTD. SHOULD BE TREATED AS SKF (UK) LTD. (A-412-201-012) WHICH CONTINUES TO BE SUBJECT TO THE ANITIDUMPING DUTY ORDER ON BALL BEARINGS AND PARTS THEREOF FROM THE UNITED KINGDOM.

3. ACCORDINGLY, FOR SHIPMENTS OF BALL BEARINGS AND PARTS THEREOF FROM THE UNITED KINGDOM ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 11/04/2009, CBP SHALL REQUIRE A CASH DEPOSIT OF ESTIMATED ANTIDUMPING DUTIES AT THE FOLLOWING PERCENTAGE RATE:
