THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (74 FR 63718) ON 12/04/2009 THE FINAL RESULTS OF ADMINISTRATIVE REVIEW OF A CERTAIN EXPORTER SUBJECT TO THE ANTIDUMPING ORDER ON POLYETHYLENE RETAIL CARRIER BAGS FROM THE PEOPLE'S REPUBLIC OF CHINA (PRC) FOR THE PERIOD 08/01/2007 THROUGH 07/31/2008.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATE HAS

BEEN REVISED FOR A CERTAIN EXPORTER. THEREFORE, FOR SHIPMENTS OF POLYETHYLENE RETAIL CARRIER BAGS FROM THE PRC ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 12/04/2009, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING EXPORTER:
