ON NOVEMBER 5, 2009, THE INTERNATIONAL TRADE COMMISSION (ITC) PUBLISHED IN THE FEDERAL REGISTER (74 FR 57329) ITS NEGATIVE FINAL DETERMINATION IN THE COUNTERVAILING DUTY INVESTIGATION OF NI-RESIST PISTON INSERTS FROM ARGENTINA. THE COUNTERVAILING DUTY INVESTIGATION OF NI-RESIST PISTON INSERTS FROM ARGENTINA HAS BEEN TERMINATED.

2. FIELD OFFICES SHOULD DISCONTINUE SUSPENSION OF LIQUIDATION OF SHIPMENTS OF MERCHANDISE ENTERED, OR WITHDRAWN FROM WAREHOUSE,

FOR CONSUMPTION ON OR AFTER JULY 6, 2009. ALL ESTIMATED COUNTERVAILING DUTIES DEPOSITED ON ENTRIES OF THE SUBJECT MERCHANDISE SHALL BE REFUNDED AND THE BONDS OR OTHER SECURITY RELEASED AT THE TIME OF LIQUIDATION.

3. NOTICE OF THE LIFTING OF SUSPENSION OF LIQUIDATION OF ENTRIES OF MERCHANDISE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER JULY 6, 2009, OCCURRED WITH THE PUBLICATION OF THE NOTICE OF TERMINATION OF THE COUNTERVAILING DUTY INVESTIGATION (74 FR 57329, NOVEMBER 5, 2009).

4. INTEREST PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930 DO NOT APPLY.
