ON 11/16/2009 THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF
ONE MANUFACTURER/EXPORTER SUBJECT TO THE ANTIDUMPING DUTY ORDER

ON POLYETHYLENE RETAIL CARRIER BAGS FROM MALAYSIA FOR THE
PERIOD 08/01/2007 THROUGH 07/31/2008.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATE HAS
BEEN REVISED FOR A CERTAIN MANUFACTURER/EXPORTER. THEREFORE,

FOR SHIPMENTS OF POLYETHYLENE RETAIL CARRIER BAGS FROM MALAYSIA ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 11/16/2009, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING MANUFACTURER/EXPORTER:

EURO PLASTICS MALAYSIA SDN. BHD.

3. IF ANY ENTRIES OF MERCHANDISE ARE EXPORTED BY A FIRM OTHER THAN THE MANUFACTURER, THEN THE FOLLOWING INSTRUCTIONS APPLY:

4. FOR ALL MANUFACTURERS/EXPORTERS OF POLYETHYLENE RETAIL CARRIER BAGS FROM MALAYSIA WITHOUT THEIR OWN RATE, THE CASH DEPOSIT RATE IS 84.94 PERCENT.

5. THESE CASH DEPOSIT REQUIREMENTS SHALL REMAIN IN EFFECT UNTIL FURTHER NOTICE. DO NOT LIQUIDATE ANY ENTRIES OF MERCHANDISE INCLUDED IN THIS ADMINISTRATIVE REVIEW UNTIL ASSESSMENT INSTRUCTIONS ARE RECEIVED.
