THE DEPARTMENT OF COMMERCE HAS COMPLETED ITS ADMINISTRATIVE REVIEW OF THE COUNTERVAILING DUTY ORDER ON CERTAIN ROUND SHAPE AGRICULTURAL TILLAGE TOOLS FROM BRAZIL (C-351-406) FOR THE PERIOD JANUARY 1, 1990 THROUGH DECEMBER 31, 1990. THE FINAL RESULTS WERE PUBLISHED IN THE FEDERAL REGISTER ON MAY 28, 1992 (57 FR 22461).

2. IMPORTS COVERED BY THE REVIEW ARE SHIPMENTS OF CERTAIN ROUND-SHAPED AGRICULTURAL TILLAGE TOOLS (DISC) WITH PLAIN OR

NOTCHED EDGE, SUCH AS COLTERS AND FURROW-OPENER BLADES FROM BRAZIL. DURING THE REVIEW PERIOD, SUCH MERCHANDISE WAS CLASSIFIABLE UNDER ITEM NUMBERS 8432.21.00, 8432.29.00, 8432.80.00 AND 8432.90.00 OF THE HARMONIZED TARIFF SCHEDULE.

3. ACCORDINGLY, FOR SHIPMENTS OF CERTAIN ROUND SHAPED AGRICULTURAL TILLAGE TOOLS FROM BRAZIL ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER MAY 28, 1992, YOU SHALL WAIVE COLLECTION OF A CASH DEPOSIT FOR ALL FIRMS.

4. THESE CASH DEPOSIT REQUIREMENTS/WAIVER WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS OF THE NEXT ADMINISTRATIVE REVIEW.

DO NOT LIQUIDATE ANY ENTRIES OF THIS MERCHANDISE INCLUDED IN THIS ADMINISTRATIVE REVIEW UNTIL ASSESSMENT INSTRUCTIONS ARE RECEIVED.
