1. COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (74 FR 65518)  
ON 12/10/2009. THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW  
OF CERTAIN MANUFACTURERS/EXPORTERS SUBJECT TO THE ANTIDUMPING  
ORDER ON CERTAIN HOT-ROLLED CARBON STEEL FLAT PRODUCTS FROM  
THAILAND FOR THE PERIOD 11/01/2007 THROUGH 10/31/2008.

2. IN THE ABOVE REFERENCED PROCEEDING, THE DEPARTMENT FOUND  
THAT G J STEEL PUBLIC COMPANY LIMITED IS THE

SUCCESSOR-IN-INTEREST TO NAKORNTHAI STRIP MILL PUBLIC CO. LTD. (A-549-817-003) FOR ANTIDUMPING DUTY CASH DEPOSIT PURPOSES. THE DEPARTMENT ALSO FOUND THAT G STEEL PUBLIC COMPANY LIMITED AND G J STEEL PUBLIC COMPANY LIMITED CONSTITUTE A COLLAPSED SINGLE ENTITY FOR THE PURPOSES OF THE REVIEW.

3. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES HAVE BEEN REVISED FOR CERTAIN MANUFACTURERS/EXPORTERS. THEREFORE, FOR SHIPMENTS OF CERTAIN HOT-ROLLED CARBON STEEL FLAT PRODUCTS FROM THAILAND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 12/10/2009, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING MANUFACTURERS/EXPORTERS:

PRODUCER: G STEEL PUBLIC COMPANY LIMITED

4. IF ANY ENTRIES OF MERCHANDISE ARE EXPORTED BY A FIRM OTHER THAN THE MANUFACTURER, THEN THE FOLLOWING INSTRUCTIONS APPLY:

A. IF THE EXPORTER OF THE SUBJECT MERCHANDISE HAS ITS OWN RATE, USE THE EXPORTER'S RATE TO DETERMINE THE CASH DEPOSIT RATE.

B. IF THE EXPORTER OF THE SUBJECT MERCHANDISE DOES NOT HAVE ITS OWN RATE, BUT THE MANUFACTURER HAS ITS OWN RATE, THE CASH DEPOSIT RATE WILL BE THE MANUFACTURER'S RATE.

C. WHERE NEITHER THE EXPORTER NOR THE MANUFACTURER CURRENTLY HAS ITS OWN RATE OR THE MANUFACTURER IS UNKNOWN, USE THE "ALL OTHER" RATE FOR ESTABLISHING THE CASH DEPOSIT RATE.

5. FOR ALL MANUFACTURERS/EXPORTERS OF CERTAIN HOT-ROLLED CARBON STEEL FLAT PRODUCTS FROM THAILAND WITHOUT THEIR OWN RATE, THE CASH DEPOSIT RATE IS 3.86 PERCENT.

6. THESE CASH DEPOSIT REQUIREMENTS SHALL REMAIN IN EFFECT UNTIL FURTHER NOTICE. DO NOT LIQUIDATE ANY ENTRIES OF MERCHANDISE INCLUDED IN THIS ADMINISTRATIVE REVIEW UNTIL ASSESSMENT INSTRUCTIONS ARE RECEIVED.
