THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (75 FR 3201) ON 01/20/2010 THE FINAL RESULTS OF ADMINISTRATIVE REVIEW OF CERTAIN EXPORTERS SUBJECT TO THE ANTIDUMPING ORDER ON FLOOR-STANDING, METAL-TOP IRONING TABLES AND CERTAIN PARTS THEREOF FROM THE PEOPLE'S REPUBLIC OF CHINA FOR THE PERIOD 08/01/2007 THROUGH 07/31/2008.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES

HAVE BEEN REVISED FOR CERTAIN EXPORTERS. THEREFORE, FOR SHIPMENTS OF FLOOR-STANDING, METAL TOP IRONING TABLES AND CERTAIN PARTS THEREOF FROM THE PEOPLE'S REPUBLIC OF CHINA ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 01/20/2010, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING EXPORTER:
