1. ON DECEMBER 21, 2009, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON CERTAIN LINED PAPER PRODUCTS FROM THE PEOPLES REPUBLIC OF CHINA (A-570-901), FOR THE PERIOD 09/01/2007 THROUGH 08/31/2008.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE

NUMBER 09-520 AND ENJOINS LIQUIDATION OF THE ENTRIES DESCRIBED IN PARAGRAPH #3 BELOW.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WERE EXPORTED BY WATANABE PAPER PRODUCTS (SHANGHAI) CO., LTD.; WATANABE PAPER PRODUCTS (LINQING) CO., LTD.; AND HOTROCK STATIONERY (SHENZHEN) CO., LTD., (COLLECTIVELY, THE WATANABE GROUP), AND WERE ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 09/01/2007 THROUGH 08/31/2008.

ANY ENTRIES THAT ARE SET FOR LIQUIDATION MUST BE UNSET IMMEDIATELY.

CONTINUE TO SUSPEND LIQUIDATION OF THESE ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED.

4. LIQUIDATION INSTRUCTIONS FOR ENTRIES AFFECTED BY THIS INJUNCTION HAVE NOT YET BEEN ISSUED.

5. EFFECTIVE IMMEDIATELY, CBP IS INSTRUCTED TO PREVENT LIQUIDATION OF ANY ENTRIES SUBJECT TO THE ABOVE.

6. PURSUANT TO THE TERMS OF THE INJUNCTION, NO LIQUIDATION OF THE ENTRIES COVERED BY THE INJUNCTION MAY BE MADE FOR ENTRIES WHICH REMAIN UNLIQUIDATED AS OF 12/21/2009.
