FABRICS COMPANCY (CFC) ON POLYETHYLENE TEREPHTHALATE
FILM, SHEET, AND STRIP FROM CHINA (A-570-924)

1. COMMERCE RECEIVED A SCOPE RULING REQUEST FROM COATED FABRICS
COMPANY ("CFC"). COMMERCE ISSUED A FINAL SCOPE RULING ON
01/07/2010, THAT CFC'S AMORPHOUS POLYETHYLENE TEREPHTHALATE
SHEET ("APET"), GLYCOL-MODIFIED POLYETHYLENE TEREPHTHALATE
SHEET ("PETG"), AND CO-EXTRUDED AMORPHOUS POLYETHYLENE
TEREPHTHALATE SHEET WITH GLYCOL-MODIFIED POLYETHYLENE
TEREPHTHALATE SHEETS ON THE OUTER SURFACES ("GAG SHEET") ARE
NOT WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER/FINDING

COVERING POLYETHYLENE TEREPHTHALATE FILM, SHEET, AND STRIP FROM THE PEOPLE'S REPUBLIC OF CHINA (A-570-924).

2. COMMERCE DETERMINED THAT CFC'S APET, PETG, AND GAG SHEET ARE NOT BIAXIALLY ORIENTED. THEREFORE, CFC'S APET, PETG, AND GAG SHEET ARE NOT WITHIN THE SCOPE OF THE ANTIDUMPING DUTY ORDER COVERING POLYETHYLENE TEREPHTHALATE FILM, SHEET, AND STRIP FROM THE PEOPLE'S REPUBLIC OF CHINA.

3. EFFECTIVE 05/05/2008, TERMINATE SUSPENSION AND LIQUIDATE ALL UNLIQUIDATED ENTRIES ENTERED, OR WITHDRAWN FROM WAREHOUSE OF APET, PETG, AND GAG SHEET LISTED ABOVE.

4. REFUND ANY CASH DEPOSITS WITH INTEREST AND RELEASE ANY BONDS RELATING TO APET, PETG, AND GAG SHEET LISTED ABOVE.

5. THESE INSTRUCTIONS CONSTITUTE NOTICE OF THE LIFTING OF SUSPENSION OF LIQUIDATION OF ENTRIES OF APET, PETG, AND GAG SHEET ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 05/05/2008.

6. THE ASSESSMENT OF ANTIDUMPING DUTIES BY CBP ON SHIPMENTS OR ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. SECTION 778 REQUIRES THAT CBP PAY INTEREST ON OVERPAYMENTS, OR ASSESS INTEREST ON UNDERPAYMENTS, OF THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED ANTIDUMPING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED ANTIDUMPING DUTIES BEFORE THE DATE OF PUBLICATION OF THE ANTIDUMPING DUTY ORDER. INTEREST SHALL BE CALCULATED FROM THE DATE PAYMENT OF ESTIMATED ANTIDUMPING DUTIES IS REQUIRED THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.

7. FOR ALL OTHER SHIPMENTS OF POLYETHYLENE TEREPHTHALATE FILM,

SHEET, AND STRIP FROM THE PEOPLE'S REPUBLIC OF CHINA NOT COVERED BY PARAGRAPH #2 ABOVE, YOU SHALL, UNLESS OTHERWISE INSTRUCTED, CONTINUE TO COLLECT CASH DEPOSITS OF ESTIMATED ANTIDUMPING DUTIES FOR THE MERCHANDISE AT THE CURRENT RATES.
