1. ON 01/20/2010, THE U.S. COURT OF INTERNATIONAL TRADE ISSUED A
PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES
WHICH ARE SUBJECT TO THE ANTIDUMPING DUTY ORDER ON CERTAIN
ACTIVATED CARBON FROM THE PEOPLES REPUBLIC OF CHINA
(A-570-904), FOR THE PERIOD 10/11/2006 THROUGH 03/31/2008.

2. THIS INJUNCTION WAS ISSUED IN CONNECTION WITH COURT CASE
