2.. FOR SHIPMENTS OF POLYETHYLENE TEREPHTHALATE FILM, SHEET AND STRIP FROM THE REPUBLIC OF KOREA ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 11/17/1999, A CASH

DEPOSIT IS REQUIRED FOR THE FOLLOWING MANUFACTURER/EXPORTER:

A-580-807-001 SKC CORPORATION 0.69 PERCENT

3. IF ANY ENTRIES OF THIS MERCHANDISE ARE EXPORTED BY A FIRM OTHER THAN SKC CORPORATION THEN THE FOLLOWING INSTRUCTIONS APPLY:

A. IF THE EXPORTER OF THE SUBJECT MERCHANDISE HAS ITS OWN RATE, USE THE EXPORTER'S RATE FOR DETERMINING THE CASH DEPOSIT RATE.

B. IF THE EXPORTER OF THE SUBJECT MERCHANDISE DOES NOT HAVE ITS OWN RATE, BUT THE MANUFACTURER HAS ITS OWN RATE, THE CASH DEPOSIT RATE WILL BE THE MANUFACTURER'S RATE.

5. FOR ALL OTHER KOREAN MANUFACTURERS/EXPORTERS OF POLYETHYLENE TEREPHTHALATE FILM, SHEET AND STRIP, THE CASH DEPOSIT REQUIRED IS 21.5 PERCENT.

6. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS FOR THE NEXT ADMINISTRATIVE REVIEW. DO NOT LIQUIDATE ANY ENTRIES COVERED BY THIS REVIEW UNTIL YOU HAVE RECEIVED LIQUIDATION INSTRUCTIONS.
