1. AS A RESULT OF A FIVE-YEAR ("SUNSET") REVIEW, THE DEPARTMENT OF COMMERCE HAS REVOKED THE ANTIDUMPING DUTY ORDER ON MULTIANGLE

LASER LIGHT SCATTERING INSTRUMENTS FROM JAPAN AND PUBLISHED THE REVOCATION IN THE FEDERAL REGISTER ON 09/01/1999. THE EFFECTIVE DATE OF THE REVOCATION IS 01/01/2000.

2. THEREFORE, CUSTOMS IS DIRECTED TO TERMINATE THE SUSPENSION OF LIQUIDATION FOR ALL SHIPMENTS OF MULTIANGLE LASER LIGHT

SCATTERING INSTRUMENTS FROM JAPAN ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 01/01/2000.

3. ALL SUSPENDED ENTRIES OF THE SUBJECT PRODUCT ENTERED OR WITHDRAWN FROM WAREHOUSE PRIOR TO 01/01/2000 SHOULD NOT, REPEAT NOT, BE LIQUIDATED UNTIL YOU RECEIVE SEPARATE AND SPECIFIC LIQUIDATION INSTRUCTIONS.
