1. THE DEPARTMENT OF COMMERCE PUBLISHED IN THE FEDERAL REGISTER 10/22/1999, 64 FR 57038, THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF THE COUNTERVAILING DUTY ORDER (C-401-401) ON CERTAIN STEEL PRODUCTS FROM SWEDEN FOR THE 01/01/1997-12/31/1997 PERIOD.
2. IMPORTS COVERED BY THE REVIEW ARE SHIPMENTS OF CERTAIN CARBON STEEL PRODUCTS FROM SWEDEN. THESE PRODUCTS INCLUDE COLD-ROLLED CARBON STEEL, FLAT-ROLLED PRODUCTS, WHETHER OR NOT CORRUGATED, OR

CRIMPED: WHETHER OR NOT PICKLED, NOT CUT, NOT PRESSED AND NOT STAMPED TO NON-RECTANGULAR SHAPE; NOT COATED OR PLEATED WITH METAL AND NOT CLAD; OVER 12 INCHES IN WIDTH AND OF ANY THICKNESS; WHETHER OR NOT IN COILS. DURING THE REVIEW PERIOD, SUCH MERCHANDISE WAS CLASSIFIABLE UNDER THE HARMONIZED TARIFF SCHEDULE

("HTS") ITEM NUMBERS 7209.11.0000, 7209.12.0000, 7209.13.0000, 7209.21.0000, 7209.22.0000, 7209.23.0000, 7209.24.5000, 7209.31.0000, 7209.32.0000, 7209.33.0000, 7209.34.0000, 7209.41.0000, 7209.43.0000, 7209.44.0000, 7209.90.0000, 7211.30.5000, 7211.41.7000 AND 7211.49.5000. THE WRITTEN DESCRIPTION REMAINS DISPOSITIVE.

3. THE NET SUBSIDY WAS FOUND TO BE 0.72 PERCENT AD VALOREM FOR THE PERIOD 01/01/1997-12/31/1997.

4. ACCORDINGLY, YOU ARE TO LIQUIDATE AT 0.72 PERCENT OF THE ENTERED VALUE ALL SHIPMENTS OF CERTAIN STEEL PRODUCTS FROM SWEDEN EXPORTED ON OR AFTER 01/01/1997 AND ON OR BEFORE 12/31/1997.

5. THE ASSESSMENT OF COUNTERVAILING DUTIES BY THE CUSTOMS SERVICE ON SHIPMENTS OR ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. SECTION 778 REQUIRES THAT CUSTOMS PAY INTEREST ON OVERPAYMENTS OR ASSESS INTEREST ON UNDERPAYMENTS, OF THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED COUNTERVAILING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED COUNTERVAILING DUTIES BEFORE THE DATE OF PUBLICATION OF THE COUNTERVAILING DUTY ORDER. INTEREST SHALL BE CALCULATED FROM THE DATE OF PAYMENT OF ESTIMATED COUNTERVAILING DUTIES THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.

6. THE SUSPENSION OF LIQUIDATION ORDERED FOR THIS MERCHANDISE EXPORTED ON OR BEFORE 12/31/1997 IS LIFTED. SUSPENSION OF LIQUIDATION FOR ALL ENTRIES OF THIS MERCHANDISE EXPORTED AFTER

12/31/1997 WILL CONTINUE.
