CORROSION-RESISTANT CARBON STEEL FLAT PRODUCTS FROM
GERMANY (A-428-815, C-428-208)

1. AS A RESULT OF A NOTIFICATION FROM THE PETITIONERS, BETHLEHEM STEEL CORPORATION, ISPAT INLAND STEEL, LTV STEEL COMPANY, INC., NATIONAL STEEL CORPORATION, AND U.S. STEEL GROUP, A UNIT OF USX CORPORATION, THAT THEY ARE NO LONGER INTERESTED IN CERTAIN CORROSION-RESISTANT CARBON STEEL FLAT PRODUCTS FROM GERMANY, THE

DEPARTMENT OF COMMERCE HAS REVOKED THESE ANTIDUMPING DUTY AND COUNTERVAILING DUTY ORDERS IN PART WITH RESPECT TO THE STEEL DESCRIBED BELOW, AND PUBLISHED THE REVOCATION IN THE FEDERAL

REGISTER ON 09/22/99. THE STEEL PRODUCTS ARE DESCRIBED AS CERTAIN CORROSION-RESISTANT CARBON STEEL FLAT PRODUCTS THAT ARE DEEP-DRAWING CARBON STEEL STRIP, ROLL-CLAD ON BOTH SIDES WITH ALUMINUM (AISI) FOILS IN ACCORDANCE WITH St3 LG AS TO EN 10139/10140. THE MERCHANDISE'S CHEMICAL COMPOSITION ENCOMPASSES A CORE MATERIAL OF U St 23 (CONTINUOUS CASTING) IN WHICH CARBON IS LESS THAN 0.08; MANGANESE IS LESS THAN 0.30; PHOSPHOROUS IS LESS THAN 0.20; SULFUR IS LESS THAN 0.015; ALUMINUM IS LESS THAN 0.01; AND THE CLADDING MATERIAL IS A MINIMUM OF 99% ALUMINUM WITH SILICON/ COPPER/IRON OF LESS THAN 1%. THE PRODUCTS ARE IN STRIPS WITH THICKNESSES OF 0.07 MM TO 4.0 MM (INCLUSIVE) AND WIDTHS OF 5 MM TO 800 MM (INCLUSIVE). THE THICKNESS RATIO OF ALUMINUM ON EITHER SIDE OF STEEL MAY RANGE FROM 3%/94%/3% TO 10%/80%/10%.

2. THEREFORE, CUSTOMS IS DIRECTED TO TERMINATE THE SUSPENSION OF LIQUIDATION FOR ALL UNLIQUIDATED ENTRIES OF CERTAIN CORROSION-RESISTANT CARBON STEEL FLAT PRODUCTS FROM GERMANY, AS DESCRIBED ABOVE, NOT COVERED BY THE FINAL RESULTS OF AN ADMINISTRATIVE REVIEW. ALL UNLIQUIDATED ENTRIES OF DEEP-DRAWING CARBON STEEL STRIP, ROLL-CLAD ON BOTH SIDES WITH ALUMINUM (AISI) FOILS IN ACCORDANCE WITH St3 LG AS TO EN 10139/10140 (AS DESCRIBED ABOVE) SHOULD BE LIQUIDATED WITHOUT REGARD TO ANTIDUMPING DUTIES (I.E., RELEASE ALL BONDS AND REFUND ALL CASH DEPOSITS).

3. THE ASSESSMENT OF ANTIDUMPING DUTIES BY THE CUSTOMS SERVICE ON ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT 1930. SECTION 778 REQUIRES THAT CUSTOMS PAYS INTEREST ON OVERPAYMENTS AND ASSESS INTEREST ON UNDERPAYMENTS OF THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED ANTIDUMPING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED ANTIDUMPING DUTIES BEFORE THE DATE OF PUBLICATION OF THE ANTIDUMPING DUTY ORDER. INTEREST SHALL BE CALCULATED FROM THE DATE OF PAYMENT OF ESTIMATED ANTIDUMPING DUTIES THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.
