1. THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (65 FR 13717) ON 03/14/2000 THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF A CERTAIN MANUFACTURER/EXPORTER SUBJECT TO THE ANTIDUMPING ORDER ON STAINLESS STEEL BAR FROM JAPAN FOR THE PERIOD 02/01/1998 THROUGH 01/31/1999.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATE HAS BEEN REVISED FOR AICHI STEEL CORPORATION. THEREFORE, FOR SHIPMENTS OF STAINLESS STEEL BAR FROM JAPAN ENTERED, OR

WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 03/14/2000, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR AICHI STEEL CORPORATION.

4. FOR ALL MANUFACTURERS OR EXPORTERS OF STAINLESS STEEL BAR FROM JAPAN WITHOUT THEIR OWN RATE, THE CASH DEPOSIT RATE IS 61.47 PERCENT.

5. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS FOR THE NEXT ADMINISTRATIVE REVIEW. DO NOT LIQUIDATE ANY ENTRIES COVERED BY THIS REVIEW UNTIL YOU HAVE RECEIVED LIQUIDATION INSTRUCTIONS.
