1. ON 08/31/1999, THE DEPARTMENT OF COMMERCE RESCINDED THE ADMINISTRATIVE REVIEW COVERING THE PERIOD 08/01/1997 THROUGH 07/31/1998 FOR OIL COUNTRY TUBULAR GOODS FROM JAPAN FOR OKURA & COMPANY WITHOUT REGARD TO ANTIDUMPING DUTIES.

2. THIS E-MAIL MESSAGE CONSTITUTES THE IMMEDIATE LIFTING OF

SUSPENSION OF LIQUIDATION OF ENTRIES FOR THE FIRM AND MERCHANDISE LISTED ABOVE DURING THE INDICATED PERIOD. ALL ENTRIES FOR THE FIRM AND MERCHANDISE LISTED ABOVE IN THE PERIOD INDICATED SHOULD BE LIQUIDATED WITHOUT REGARD TO ANTIDUMPING DUTIES. FOR ALL OTHER SHIPMENTS OF OIL COUNTRY TUBULAR GOODS FROM JAPAN YOU SHALL, UNLESS OTHERWISE INSTRUCTED, CONTINUE TO COLLECT CASH DEPOSITS OF ESTIMATED ANTIDUMPING DUTIES FOR THE MERCHANDISE AT THE CURRENT RATES.

4. THE ASSESSMENT OF ANTIDUMPING DUTIES BY THE CUSTOMS SERVICE ON ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. SECTION 778 REQUIRES THAT CUSTOMS PAY INTEREST ON OVERPAYMENTS AND ASSESS INTEREST ON UNDERPAYMENTS OF THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED ANTIDUMPING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED ANTIDUMPING DUTIES BEFORE THE DATE OF PUBLICATION OF THE ANTIDUMPING DUTY ORDER. INTEREST SHALL BE CALCULATED FROM THE DATE PAYMENT OF ESTIMATED ANTIDUMPING DUTIES IS REQUIRED THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.
