FEDERATION CONCERNING TRADE IN CERTAIN STEEL PRODUCTS FROM  
("THE COMPREHENSIVE AGREEMENT") (SEE MESSAGE NUMBER 9250115  
DATED SEPTEMBER 7, 1999), FOR MERCHANDISE ENTERED OR  
WITHDRAWN FROM WAREHOUSE FOR CONSUMPTION ON OR AFTER  
JULY 12, 1999, THE U.S. CUSTOMS SERVICE REQUIRED  
PRESENTATION OF AN ORIGINAL EXPORT LICENSE AS A CONDITION

OF ENTRY OF SUBJECT MERCHANDISE. THESE INSTRUCTIONS  
REMAIN IN EFFECT.

2. EXEMPTION FROM EXPORT LICENSE REQUIREMENT FOR SPECIFIC  
WITHDRAWAL FROM WAREHOUSE ON OCTOBER 20, 1998, 2,397.84 MT OF  
STEEL PRODUCTS FROM THE RUSSIAN FEDERATION WAS ENTERED  
INTO A BONDED WAREHOUSE, UNDER WAREHOUSE ENTRY NUMBER  
8783343-3. THE DEPARTMENT OF COMMERCE HAS DETERMINED THAT  
MERCHANDISE UNDER THIS ENTRY NUMBER IS NOT SUBJECT TO THE  
COMPREHENSIVE AGREEMENT. THEREFORE, ANY WITHDRAWALS UNDER  
ENTRY NUMBER 8783343-3 MAY BE MADE WITHOUT PRESENTATION OF  
AN ORIGINAL EXPORT LICENSE.
