1. THE DEPARTMENT OF COMMERCE HAS REVOKED IN PART THE A-588-054 ANTIDUMPING FINDING ON TAPERED ROLLER BEARINGS, FOUR INCHES OR LESS IN OUTSIDE DIAMETER, AND COMPONENTS THEREOF, FROM JAPAN (A-588-054). THE NOTICE OF FINAL AND CONCLUSIVE COURT DECISIONS REGARDING THE REVOCATION WAS PUBLISHED IN THE FEDERAL REGISTER ON 04/10/2000. THE PARTIAL REVOCATION APPLIES TO ALL SUBJECT MERCHANDISE RESOLD/EXPORTED BY HONDA MOTOR CO., LTD. (HONDA). THE EFFECTIVE DATE OF THE REVOCATION IS 09/01/1981.

2. THEREFORE, CUSTOMS IS DIRECTED TO TERMINATE THE SUSPENSION OF LIQUIDATION FOR ALL SHIPMENTS OF TAPERED ROLLER BEARINGS, FOUR INCHES OR LESS IN OUTSIDE DIAMETER, AND COMPONENTS THEREOF, FROM JAPAN RESOLD/EXPORTED BY HONDA ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 09/01/1981. ALL ENTRIES OF THE SUBJECT PRODUCT RESOLD/EXPORTED BY HONDA THAT WERE SUSPENDED ON OR AFTER 09/01/1981 SHOULD BE LIQUIDATED WITHOUT REGARD TO ANTIDUMPING DUTIES (I.E., RELEASE ALL BONDS AND REFUND ALL CASH DEPOSITS).

3. THE ASSESSMENT OF ANTIDUMPING DUTIES BY THE CUSTOMS SERVICE ON ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. SECTION 778 REQUIRES THAT CUSTOMS PAYS INTEREST ON OVERPAYMENTS AND ASSESS INTEREST ON UNDERPAYMENTS OF THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED ANTIDUMPING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH OR BONDS POSTED AS ESTIMATED ANTIDUMPING DUTIES BEFORE THE DATE OF PUBLICATION OF THE ANTIDUMPING FINDING. INTEREST SHALL BE CALCULATED FROM THE DATE OF PAYMENT OF ESTIMATED ANTIDUMPING DUTIES THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.

4.
