RE: AMENDED LIQ. INSTRUCTIONS FOR ANTIFRICTIN BEARINGS (OTHER THAN ROLLER BEARINGS) FROM SWEDEN (A-401-201,203)

1. THIS IS AN AMENDMENT OF MESSAGE NUMBER 0111201 DATED 4/20/2000. IN THAT MESSAGE THERE WAS A CLERICAL ERROR WHICH STATED THE WRONG COUNTRY. THE INFORMATION BELOW IS CORRECT.

2. THE COMMERCE DEPARTMENT'S ADMINISTRATIVE REVIEWS OF THE ANTIDUMPING DUTY ORDERS ON BALL BEARINGS AND PARTS THEREOF AND CYLINDRICAL ROLLER BEARINGS AND PARTS THEREOF FROM SWEDEN (A-401-201 AND A-401-203, RESPECTIVELY), COVERING THE PERIOD 05/01/1998 THROUGH 04/30/1999, HAVE BEEN TERMINATED IN

PART. THIS NOTICE OF PARTIAL TERMINATION WAS PUBLISHED IN THE FEDERAL REGISTER ON 04/06/2000.

3. ACCORDINGLY, YOU ARE TO ASSESS ANTIDUMPING DUTIES ON BALL BEARINGS, AND CYLINDRICAL ROLLER BEARINGS FROM SWEDEN MANUFACTURED BY THE COMPANY LISTED BELOW AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 05/01/1998 THROUGH 04/30/1999 AT THE CASH DEPOSIT RATE REQUIRED AT THE TIME OF ENTRY.

MANUFACTURER OR EXPORTER:

4. THESE INSTRUCTIONS CONSTITUTE THE IMMEDIATE LIFTING OF SUSPENSION OF LIQUIDATION OF ENTRY SUMMARIES FOR THE MERCHANDISE AND PERIOD LISTED ABOVE. YOU SHALL CONTINUE TO COLLECT CASH DEPOSITS OF ESTIMATED ANTIDUMPING DUTIES FOR THE MERCHANDISE AT THE CURRENT RATES.

5. THE ASSESSMENT OF ANTIDUMPING DUTIES BY THE CUSTOMS SERVICE ON ENTRIES OF THIS MERCHANDISE IS SUBJECT TO THE PROVISIONS OF SECTION 778 OF THE TARIFF ACT OF 1930. SECTION 778 REQUIRES THAT CUSTOMS PAY INTEREST ON OVERPAYMENTS AND ASSESS INTEREST ON UNDERPAYMENTS OF THE REQUIRED AMOUNTS DEPOSITED AS ESTIMATED ANTIDUMPING DUTIES. THE INTEREST PROVISIONS ARE NOT APPLICABLE TO CASH BONDS POSTED AS ESTIMATED ANTIDUMPING DUTIES BEFORE THE DATE OF PUBLICATION OF THE ANTIDUMPING DUTY ORDER. INTEREST SHALL BE CALCULATED FROM THE DATE OF PAYMENT OF ESTIMATED ANTIDUMPING DUTIES THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.

6. UPON ASSESSMENT OF ANTIDUMPING DUTIES, CUSTOMS SHOULD REQUIRE THAT THE IMPORTER PROVIDE A REIMBURSEMENT STATEMENT AS DESCRIBED IN SECTION 351.402 OF THE COMMERCE DEPARTMENT REGULATIONS. THE IMPORTER SHOULD PROVIDE THE REIMBURSEMENT STATEMENT PRIOR TO LIQUIDATION OF THE ENTRY. IF THE IMPORTER CERTIFIES THAT IT HAS

AN AGREEMENT WITH THE EXPORTER TO BE REIMBURSED ANTIDUMPING DUTIES, CUSTOMS SHOULD DOUBLE THE ANTIDUMPING DUTIES IN ACCORDANCE WITH THE ABOVE-REFERENCED REGULATION. ADDITIONALLY, IF THE IMPORTER FAILS TO RESPOND TO YOUR FORMAL REQUEST (VIA CF 28 OR 29) FOR THE REIMBURSEMENT STATEMENT PRIOR TO LIQUIDATION, CUSTOMS SHOULD PRESUME REIMBURSEMENT AND DOUBLE THE ANTIDUMPING DUTIES DUE.

7.
