ON 06/02/2000, THE U.S. COURT OF INTERNATIONAL TRADE (THE COURT) ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF ENTRIES OF TAPERED ROLLER BEARINGS SUBJECT TO THE ANTIDUMPING FINDING ON TAPERED ROLLER BEARINGS, FOUR INCHES OR LESS IN OUTSIDE DIAMETER, AND COMPONENTS THEREOF, FROM JAPAN, CASE NUMBER

A-588-054, AND MANUFACTURED AND/OR EXPORTED BY NSK, LTD. AND/OR NSK CORPORATION (NSK), AND ENTERED, OR WITHDRAWN FROM WAREHOUSE,

FOR CONSUMPTION DURING THE PERIOD 10/01/1997 THROUGH 09/30/1998.

2. IN ADDITION, ON 06/02/2000, THE COURT ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF ENTRIES OF TAPERED ROLLER BEARINGS SUBJECT TO THE ANTIDUMPING DUTY ORDER ON TAPERED ROLLER BEARINGS AND PARTS THEREOF, FINISHED AND UNFINISHED, FROM JAPAN, CASE NUMBER A-588-604, AND MANUFACTURED AND/OR EXPORTED BY NSK, AND ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 10/01/1997 THROUGH 09/30/1998.

3. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF SUBJECT MERCHANDISE WHICH WAS PRODUCED/EXPORTED BY NSK AND WHICH WAS ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD 10/01/1997 THROUGH 09/30/1998. CONTINUE TO SUSPEND LIQUIDATION OF OTHER ENTRIES UNTIL LIQUIDATION INSTRUCTIONS ARE PROVIDED. ANY ENTRIES WHICH MAY BE SET FOR LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
