1. THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (65 FR 55005) ON 09/12/2000, THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF CERTAIN MANUFACTURERS/EXPORTERS SUBJECT

TO THE ANTIDUMPING ORDER ON STATIC RANDOM ACCESS MEMORY SEMICONDUCTORS FROM TAIWAN FOR THE PERIOD 10/01/1997 THROUGH 03/31/1999 FOR G-LINK TECHNOLOGY, INC. AND WINBOND ELECTRONICS CORPORATION AND FOR THE PERIOD 10/01/1998 THROUGH 03/31/1999 FOR GIGA SEMICONDUCTOR, INC. (A.K.A. GSI TECHNOLOGY).

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES HAVE BEEN REVISED FOR CERTAIN MANUFACTURERS/EXPORTERS. THEREFORE, FOR SHIPMENTS OF STATIC RANDOM ACCESS MEMORY SEMICONDUCTORS FROM TAIWAN ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 09/12/2000, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING MANUFACTURERS/EXPORTERS:

G-LINK, TECHNOLOGY, INC.      A-583-827-010      32.12%

GIGA SEMICONDUCTOR, INC.,  
(GSI TECHNOLOGY)      A-583-827-008      33.85%

WINBOND ELECTRONICS CORP.      A-583-827-007      0.67%

3. IF ANY ENTRIES OF THIS MERCHANDISE ARE EXPORTED BY A FIRM OTHER THAN THE MANUFACTURER, THEN THE FOLLOWING INSTRUCTIONS APPLY:

A. IF THE EXPORTER OF THE SUBJECT MERCHANDISE HAS ITS OWN RATE, USE THE EXPORTER'S RATE FOR DETERMINING THE CASH DEPOSIT RATE.

4. FOR ALL MANUFACTURERS/EXPORTERS OF STATIC RANDOM ACCESS MEMORY SEMICONDUCTORS FROM TAIWAN WITHOUT THEIR OWN RATE, THE CASH DEPOSIT RATE IS 41.75%.

5. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL

PUBLICATION OF THE FINAL RESULTS FOR THE NEXT ADMINISTRATIVE REVIEW. DO NOT LIQUIDATE ANY ENTRIES COVERED BY THIS REVIEW UNTIL YOU HAVE RECEIVED LIQUIDATION INSTRUCTIONS.
