THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (65 FR 47958) ON 08/04/2000 THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF A NEW SHIPPER SUBJECT TO THE ANTIDUMPING DUTY ORDER ON FRESHWATER CRAWFISH TAIL MEAT FROM THE PEOPLE'S REPUBLIC OF CHINA FOR THE PERIOD 09/01/1998 THROUGH 02/28/1999.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATE HAS BEEN REVISED FOR A CERTAIN EXPORTER. THEREFORE, FOR SHIPMENTS OF FRESHWATER CRAWFISH TAIL MEAT FROM THE PEOPLE'S REPUBLIC OF CHINA

ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER

08/04/2000, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING EXPORTER:

3. IF ANY ENTRIES OF THE MERCHANDISE ARE EXPORTED BY A FIRM OTHER THAN THE MANUFACTURER, THEN THE FOLLOWING INSTRUCTIONS APPLY:

4. FOR ALL MANUFACTURERS/EXPORTERS OF FRESHWATER CRAWFISH TAIL MEAT FROM THE PEOPLE'S REPUBLIC OF CHINA WITHOUT THEIR OWN RATE, THE CASH DEPOSIT RATE IS 201.63 PERCENT.

5. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS FOR THE NEXT ADMINISTRATIVE REVIEW. DO NOT LIQUIDATE ANY ENTRIES COVERED BY THIS REVIEW UNTIL YOU HAVE RECEIVED LIQUIDATION INSTRUCTIONS.
