1. THE DEPARTMENT OF COMMERCE PUBLISHED IN THE FEDERAL REGISTER  
(65 FR 37520) ON 06/15/2000 THE FINAL RESULTS OF ITS  
ADMINISTRATIVE REVIEW OF CERTAIN MANUFACTURERS/EXPORTERS SUBJECT  
TO THE ANTIDUMPING ORDER ON BRASS SHEET AND STRIP FROM CANADA  
(A-122-601), FOR THE PERIOD 01/01/1998 THROUGH 12/31/1998.

2. AS A RESULT OF COMMERCE'S REVIEW, THE CASH DEPOSIT RATES HAVE  
BEEN REVISED FOR CERTAIN MANUFACTURERS/EXPORTERS. THEREFORE, FOR

SHIPMENTS OF BRASS SHEET AND STRIP FROM CANADA ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 01/01/1998, THE REQUIRED CASH DEPOSIT HAS BEEN REVISED FOR THE FOLLOWING MANUFACTURERS/EXPORTERS:

WOLVERINE TUBE (CANADA), INC.    A-122-601-004    3.38%

3. IF ANY ENTRIES OF THIS MERCHANDISE ARE EXPORTED BY A FIRM OTHER THAN THE MANUFACTURER, THEN THE FOLLOWING INSTRUCTIONS APPLY:

4. FOR ALL MANUFACTURERS/EXPORTERS OF BRASS SHEET AND STRIP FROM CANADA WITHOUT THEIR OWN RATE, THE CASH DEPOSIT RATE IS 8.10 PERCENT.

5. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS FOR THE NEXT ADMINISTRATIVE REVIEW. DO NOT LIQUIDATE ANY ENTRIES COVERED BY THIS REVIEW UNTIL YOU HAVE RECEIVED LIQUIDATION INSTRUCTIONS.
