1. AS A RESULT OF NOTIFICATION FROM THE PETITIONERS, THE AMERICAN HONEY PRODUCERS ASSOCIATION AND THE AMERICAN BEEKEEPING FEDERATION, INC., THAT THEY ARE NO LONGER INTERESTED IN THE SUSPENDED INVESTIGATION ON HONEY FROM CHINA, THE DEPARTMENT OF COMMERCE

HAS TERMINATED THE SUSPENDED INVESTIGATION AND PUBLISHED THE TERMINATION IN THE FEDERAL REGISTER ON JULY 28, 2000 (65 FR

46427).

2. THEREFORE, QUOTA CERTIFICATES/CERTIFICATES OF ORIGIN, AS WELL AS WRITTEN CERTIFICATIONS FROM IMPORTERS OF RECORD STATING THAT THE HONEY WAS NOT OBTAINED UNDER ANY ARRANGEMENT, SWAP, EXCHANGE,

OR OTHER TRANSACTION DESIGNED TO CIRCUMVENT THE AGREEMENT, WILL NO LONGER BE REQUIRED FOR ENTRY RELEASE OF HONEY FROM CHINA OR ANY OTHER COUNTRY ON OR AFTER AUGUST 16, 2000. IN ADDITION, FORWARDING OF IMPORT DOCUMENTATION FOR ENTRIES OF HONEY ON OR AFTER AUGUST 16, 2000 WILL NO LONGER BE REQUIRED. ANY SUSPENDED ENTRIES REMAINING SHOULD BE LIQUIDATED WITHOUT REGARD TO ANTIDUMPING DUTIES.
