THE DEPARTMENT OF COMMERCE HAS AMENDED THE FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF THE ANTIDUMPING DUTY ORDERS ON ANTIFRICTION BEARINGS (OTHER THAN TAPERED ROLLER BEARINGS) AND PARTS THEREOF FROM JAPAN FOR THE PERIOD OF 05/01/1998 THROUGH 04/30/1999.
