1. ON 11/29/2000, THE U.S. COURT OF INTERNATIONAL TRADE (C.I.T.) ISSUED A PRELIMINARY INJUNCTION ENJOINING LIQUIDATION OF CERTAIN ENTRIES OF STAINLESS STEEL WIRE ROD FROM ITALY MANUFACTURED OR EXPORTED BY ACCIAIERIE VALBRUNA S.R.L. (C-475-821-001) OR ACCIAIERIE DI BOLZANO SPA (C-475-821-003) COVERING ENTRIES FROM 1/1/1999 AND CONTINUING UNTIL FURTHER NOTICE.

2. ACCORDINGLY, UNTIL FURTHER NOTICE, DO NOT LIQUIDATE ENTRIES OF STAINLESS STEEL WIRE ROD FROM ITALY WHICH WAS PRODUCED OR

EXPORTED BY ACCIAIERIE VALBRUNA S.R.L. (C-475-821-001) OR
ACCIAIERIE DI BOLZANO SPA (C-475-821-003) AND WHICH WAS ENTERED,
OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION DURING THE PERIOD

BEGINNING 1/1/1999 AND CONTINUING UNTIL FURTHER NOTICE. CONTINUE
TO SUSPEND LIQUIDATION OF OTHER ENTRIES UNTIL LIQUIDATION
INSTRUCTIONS ARE PROVIDED. ANY ENTRIES WHICH MAY BE SET FOR
LIQUIDATION NEED TO BE UNSET IMMEDIATELY.
