RE: Preliminary injunction on wooden bedroom furniture from the PRC for Shanghai Maoji Import and Export Corporation Limited for the period 01/01/2011 through 12/31/2011 (A-570-890), court number 13-00251

1. On 07/17/2013, the U.S. Court of International Trade issued a preliminary injunction enjoining liquidation of certain entries which are subject to the antidumping duty order on wooden bedroom furniture from the People's Republic of China (A-570-890) for the period 01/01/2011 through 12/31/2011.

2. This injunction was issued in connection with court case number 13-00251 and enjoins liquidation of the entries described in paragraph 3 below.

3. Accordingly, until further notice, do not liquidate entries of subject merchandise which were produced or exported by Shanghai Maoji Import and Export Corporation Limited, imported by the importers listed below, and which were entered, or withdrawn from warehouse, for consumption between 01/01/2011 through 12/31/2011. Any entries that are set for liquidation must be unset immediately. Continue to suspend liquidation of these entries until liquidation instructions are issued:

MGM Resorts International Design,
Bryan Ashley International Inc., or
Metropolis Manufacturing Inc. (doing business as Vaughan Benz)

4. The injunction applies to the liquidation instructions in message number 3191301, dated 07/10/2013.

5. Effective immediately, CBP is instructed to prevent liquidation of any entries subject to the above.

6. The Court of International Trade entered this injunction order on the docket of this case on 07/17/2013. Pursuant to the terms of the injunction, no liquidation of the entries covered by the injunction may be made for entries which remain unliquidated as of 5:00 p.m. on the business day

after the day when the Court entered this order on the docket in this case.
