1. THIS CLARIFIES MESSAGE NO: 0049201, DATED 02/18/2000, WHICH CONTAINS LIQUIDATION INSTRUCTIONS FOR THE ADMINISTRATIVE REVIEW OF IRON-METAL CASTINGS FROM INDIA FOR THE PERIOD 01/01/1987 -12/31/1987.

2. THE DEPARTMENT OF COMMERCE HAS PUBLISHED IN THE FEDERAL REGISTER (65 FR 5612) OF 02/04/2000, THE AMENDED FINAL RESULTS OF ITS ADMINISTRATIVE REVIEW OF THE COUNTERVAILING DUTY ORDER (C-533-063) ON CERTAIN IRON-METAL CASTINGS FROM

INDIA FOR THE REVIEW PERIOD 01/01/1987 THROUGH 12/31/1987.

3. IMPORTS COVERED BY THE REVIEW ARE SHIPMENTS OF SCOPE DESCRIPTION OF THE PRODUCT AND CORRESPONDING HARMONIZED TARIFF SCHEDULE ITEM NUMBERS.

INTEREST SHALL BE CALCULATED FROM THE DATE OF PAYMENT OF ESTIMATED COUNTERVAILING DUTIES THROUGH THE DATE OF LIQUIDATION. THE RATE AT WHICH SUCH INTEREST IS PAYABLE IS THE RATE IN EFFECT UNDER SECTION 6621 OF THE INTERNAL REVENUE CODE OF 1954 FOR SUCH PERIOD.

6. THE SUSPENSION OF LIQUIDATION ORDERED FOR THIS MERCHANDISE EXPORTED ON OR BEFORE 12/31/1987 IS LIFTED. SUSPENSION OF LIQUIDATION FOR ALL ENTRIES OF THIS MERCHANDISE EXPORTED BETWEEN 01/01/1990 AND 12/31/1994 AND BETWEEN 01/01/1997 AND 12/31/1997 WILL CONTINUE.
