1. ON 01/30/2001, THE DEPARTMENT OF COMMERCE WILL PUBLISH
IN THE FEDERAL REGISTER ITS PRELIMINARY DETERMINATION OF SALES AT
LESS THAN FAIR VALUE IN THE ANTIDUMPING DUTY INVESTIGATION OF
REBAR FROM POLAND.

2. FOR PURPOSES OF THIS INVESTIGATION, THE PRODUCT COVERED IS
ALL REBAR SOLD IN STRAIGHT LENGTHS, CURRENTLY CLASSIFIABLE IN THE
HARMONIZED TARIFF SCHEDULE OF THE UNITED STATES (HTSUS) UNDER

ITEM NUMBER 7214.20.00 OR ANY OTHER TARIFF ITEM NUMBER. SPECIFICALLY EXCLUDED ARE PLAIN ROUNDS (I.E., NON-DEFORMED OR SMOOTH BARS) AND REBAR THAT HAS BEEN FURTHER PROCESSED THROUGH BENDING OR COATING. HTSUS SUBHEADINGS ARE PROVIDED FOR CONVENIENCE AND CUSTOMS PURPOSES. THE WRITTEN DESCRIPTION OF THE SCOPE OF THIS PROCEEDING IS DISPOSITIVE.

3. FOR FURTHER REPORTING PURPOSES, THIS CASE HAS BEEN ASSIGNED INVESTIGATION NUMBER A-455-803.

4. BECAUSE CRITICAL CIRCUMSTANCES WERE PREVIOUSLY FOUND TO EXIST PRELIMINARILY FOR IMPORTS OF REBAR FROM POLAND, THE CUSTOMS SERVICE SHALL SUSPEND LIQUIDATION OF SUCH SHIPMENTS ENTERED OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 11/01/2000, WHICH IS 90 DAYS PRIOR TO THE DATE OF PUBLICATION OF THE PRELIMINARY DETERMINATION IN THE FEDERAL REGISTER. CUSTOMS SHALL REQUIRE A CASH DEPOSIT OR THE POSTING OF A BOND EQUAL TO THE MARGINS SHOWN BELOW:
