THE DEPARTMENT OF COMMERCE IS CONDUCTING NEW SHIPPER REVIEWS OF THE ANTIDUMPING DUTY ORDER ON TAPERED ROLLER BEARINGS AND PARTS THEREOF, FINISHED AND UNFINISHED, FROM THE PEOPLE'S REPUBLIC OF CHINA FOR THE PERIOD JUNE 1, 2000 THROUGH NOVEMBER 30, 2000. THE NOTICE OF THE INITIATION OF REVIEW WAS PUBLISHED IN THE FEDERAL REGISTER ON JANUARY 31, 2001.

2. FOR SHIPMENTS OF TAPERED ROLLER BEARINGS AND PARTS THEREOF,

FINISHED AND UNFINISHED ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION IN THE UNITED STATES ON OR AFTER JANUARY 31, 2001, A BOND OR OTHER SECURITY DEPOSIT IS PERMITTED, AT THE IMPORTER'S OPTION, FOR THE FOLLOWING NEW MANUFACTURERS/EXPORTERS:

5. THE OPTION OF A BOND IN LIEU OF A CASH DEPOSIT WILL REMAIN IN EFFECT FOR PEER BEARING COMPANY - CHANGSHAN AND YANTAI TIMKEN COMPANY LIMITED UNTIL PUBLICATION OF THE FINAL RESULTS OF THE NEW SHIPPER REVIEWS.
