2. FOR SHIPMENTS OF CERTAIN PASTA FROM TURKEY ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 3/13/2001, NO CASH DEPOSIT IS REQUIRED FOR THE FOLLOWING CUSTOMS ID NUMBER

4. FOR ALL MANUFACTURERS/EXPORTERS OF CERTAIN PASTA FROM TURKEY WITHOUT THEIR OWN RATE, THE CASH DEPOSIT RATE IS 51.49 PERCENT WHICH IS NET OF THE PORTION OF THE MARGIN ATTRIBUTABLE TO THE EXPORT SUBSIDY FROM THE COUNTERVAILING DUTY INVESTIGATION.

5. THESE CASH DEPOSIT REQUIREMENTS WILL REMAIN IN EFFECT UNTIL PUBLICATION OF THE FINAL RESULTS FOR THE NEXT ADMINISTRATIVE REVIEW. DO NOT LIQUIDATE ANY ENTRIES COVERED BY THIS REVIEW UNTIL YOU HAVE RECEIVED LIQUIDATION INSTRUCTIONS.
