1. THE DEPARTMENT OF COMMERCE HAS RESCINDED A NEW SHIPPER
ADMINISTRATIVE REVIEW OF THE ANTIDUMPING DUTY ORDER ON FRESHWATER

CRAWFISH TAIL MEAT FROM THE PEOPLE'S REPUBLIC OF CHINA (PRC) (A-
570-848) FOR THE PERIOD 03/26/1997 TO 08/31/1998.

2. THE NOTICE OF RESCISSION OF NEW SHIPPER ANITDUMPING DUTY
REVIEW WITH RESPECT TO YANCHENG BAOLONG BIOCHEMICAL PRODUCTS WAS

PUBLISHED IN THE FEDERAL REGISTER ON 04/19/2000 (65 FR 20948).

3. ACCORDINGLY, FOR SHIPMENTS OF FRESHWATER CRAWFISH TAIL MEAT ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION ON OR AFTER 11/05/1998, THE OPTION OF A BOND IN LIEU OF A CASH DEPOSIT IS NOT PERMITTED. ACCORDINGLY, YOU SHALL COLLECT A CASH DEPOSIT FROM YANCHENG BAOLONG BIOCHEMICAL (A-570-848-015) AT THE PRC COUNTRY-WIDE RATE OF 201.63 PERCENT.

4. FOR ALL OTHER COMPANIES NAMED IN THE ANTIDUMPING DUTY MODULE, THE CASH DEPOSIT RATE IS THE RATE PROVIDED THEREIN.

5. FOR ALL OTHER CHINESE MANUFACTURERS/EXPORTERS OF FRESHWATER CRAWFISH TAIL MEAT FROM THE PEOPLE'S REPUBLIC OF CHINA WHICH DO NOT HAVE A SPECIFIC RATE IN THE MODULE, THE CASH DEPOSIT RATE CONTINUES TO BE 201.63 PERCENT.
