1. THE DEPARTMENT OF COMMERCE IS CONDUCTING A NEW SHIPPER REVIEW OF THE ANTIDUMPING DUTY ORDER ON CERTAIN PRESERVED MUSHROOMS FROM

THE PEOPLE'S REPUBLIC OF CHINA FOR THE PERIOD OF FEBRUARY 1, 2000, THROUGH JANUARY 31, 2001. THE NOTICE OF THE INITIATION OF REVIEW WILL BE PUBLISHED IN THE FEDERAL REGISTER ON MARCH 30, 2001.

2. FOR SHIPMENTS OF CERTAIN PRESERVED MUSHROOMS FROM THE PEOPLE'S REPUBLIC OF CHINA ENTERED, OR WITHDRAWN FROM WAREHOUSE, FOR CONSUMPTION IN THE U.S. ON OR AFTER MARCH 30, 2001, A BOND OR OTHER SECURITY DEPOSIT IS PERMITTED, AT THE IMPORTER'S OPTION, FOR THE FOLLOWING NEW MANUFACTURERS/EXPORTERS:
